MEMORANDUM of ASSOCIATION of

Sgoil an Iochdair agus a'Choimhearsnachd

The Memorandum of Association sets out the Objects of the Company and the Powers conferred upon it to enable it to achieve its Objects, confirms the limit of liability upon its Members and explains what is to happen to any surplus assets upon its dissolution.

- 1. The name of the company is "Sgoil an Iochdair agus a'Choimhearsnachd" ("the Trust").
 - 2. The Registered Office of the Trust is situated in Scotland.
- 3. The definitions and meanings specified in Article 1 (b) of the Trust's Articles of Association shall have effect as if repeated in this Memorandum of Association.
- 4. (a) The Area of Benefit ("the Area of Benefit") shall comprise the catchment area of Iochdair School in the Uists Western Isles, embracing all townships to the east of the main road in Benbecula, all townships south of and including Griminish in Benbecula and all townships in the north end of South Uist, extending as far south as Snishival.
 - (b) The Objects of the Trust ("the Objects") shall be to promote the benefit of the inhabitants of the Area of Benefit, without distinction of sex, sexuality, political, religious or other opinions, by associating with local statutory authorities, voluntary organisations and inhabitants in a common effort to advance education and to provide facilities, or assist in the provision of facilities, in the interests of social welfare for recreation and other leisure-time occupation so that their conditions of life may be improved.
- 5. The Trust shall have the following powers (but only in furtherance of the Objects):
 - (a) To provide, develop and manage facilities, programmes and initiatives for amateur sports.
 - (b) To develop research, projects, initiatives, surveys, monitoring, training, coaching, education and amateur sporting events.
 - (c) To publish and distribute up-to-date information on amateur sports clubs and recreational organisations, activities, competitions and facilities.
 - (d) To prepare and organise, promote and implement training courses, exhibitions, lectures, seminars, conferences, events and workshops.
 - (e) To collect, collate, disseminate and exchange information and to prepare, produce, edit, publish, exhibit and distribute articles, pamphlets, books and other publications, tapes, motion and still pictures, music and drama and other materials, all in any medium.
 - (f) To purchase, take on lease, hire, or otherwise acquire, any property wheresoever situated which is suitable for the activities of the Trust and to construct, convert, improve, develop, maintain, alter and demolish any buildings or erections whether of a permanent or temporary nature, and manage and operate or arrange for the professional management and

operation of the Trust's property.

- (g) To sell, let, hire, license, give in exchange and otherwise dispose of all or any part of the property of the Trust, wheresoever situated.
- (i) To establish and administer a building fund or funds or guarantee fund or funds or endowment fund or funds.
- (j) To employ, train and pay such staff as are considered appropriate for the proper conduct of the activities of the Trust and if appropriate to make reasonable provision for the payment of pension and/or other benefits therefor.
- (k) To engage such consultants and advisers as are considered appropriate from time to time.
- (l) To effect insurance of all kinds (which may include liability insurance in respect of Trustees and employees).
- (m) To take such steps as may be deemed appropriate for the purpose of raising funds for the activities of the Trust.
- (n) To accept subscriptions, grants, donations, gifts, legacies and endowments of all kinds, either absolutely or conditionally or in trust for any of the Objects.
- (o) To borrow or raise money for the Objects and to give security in support of any such borrowings by the Trust and/or in support of any obligations undertaken by the Trust.
- (p) To invest any funds which are not immediately required for the activities of the Trust in such investments as may be considered appropriate and to dispose of, and vary, such investments.
- (q) To encourage and develop a spirit of voluntary or other commitment by individuals, organisations, authorities and others and any groups or groupings thereof willing to assist the Trust to achieve the Objects.
- (r) To establish, manage and/or support any other charitable organisation, and to make donations for any charitable purpose falling within the Objects.
- (s) To establish, operate and administer and/or otherwise acquire separate trading companies or associations, whether charitable or not.
- (t) To enter into any arrangement with any organisation, government or authority which may be advantageous for the purposes of the activities of the Trust and to enter into any arrangement for co-operation, mutual assistance, or sharing profit with any charitable organisation.
- (u) To oppose, or object to, any application or proceedings which may prejudice the interests of the Trust.
- (v) To carry out the Objects in any part of the world as principal, agent, contractor, trustee or in any other capacity and through an agent, contractor, sub-contractor, trustee or any person acting in any other capacity and either alone or in conjunction with others.
- (w) To do anything which may be incidental or conducive to the furtherance of the Objects.
- 6. (a) The income and property of the Trust shall be applied solely towards promoting the Objects.
 - (b) No part of the income or property of the Trust shall be paid or transferred (directly or indirectly) to the members of the Trust, whether by way of dividend, bonus or otherwise.
 - (c) No Trustee of the Trust shall be appointed as a paid employee of the Trust.
 - (d) No benefit (whether in money or in kind) shall be given by the Trust to any member or Trustee except the possibility of:
 - (i) Repayment of out-of-pocket expenses to Trustees (subject to prior agreement by the Board); or

- (ii) Reasonable remuneration to a member or any Trustees in return for specific services actually rendered to the Trust (not being of a management nature normally carried out by a director of a company); or
- (iii) Payment of interest at a rate not exceeding the commercial rate on money lent to the Trust by any member or Trustee; or
- (iv) payment of rent at a rate not exceeding the open market rent for property let to the Trust by any member or Trustee; or
- (v) The purchase of property from any member or Trustee at or below market value and to sell assets to any member or Trustee providing such sale is at or above market value.
- 7. The liability of the members is limited.
- 8. Every member of the Trust undertakes to contribute such amount as may be required (not exceeding £1) to the property of the Trust if it should be wound up whilst he, she or it is a member or within one year after he, she or it ceases to be a member (for whatever reason), for payment of its debts and liabilities contracted before he, she or it ceases to be a member, and of the costs, charges and expenses of winding up.
- 9. (a) The winding-up of the Trust may take place only on the decision of not less than 75% of its Ordinary Members who are present and voting at an EGM called specifically (but not necessarily exclusively) for the purpose.
 - (b) If, on the winding-up of the Trust, any property remains, after satisfaction of all its debts and liabilities, such property shall be given or transferred to any one or more charities working in the Iochdair area or the Uists and having the same or a similar object to the Objects.
 - (c) The charity or charities to which the property is to be transferred in terms of sub-clause (b) hereof shall be determined on the decision of not less than 75% of the Ordinary Members of the Trust who are present and voting at an EGM called specifically (but not necessarily exclusively) for the purpose or, failing that, by a decision of not less than 75% of the Board or, failing that, as determined by an arbiter to be chosen amicably by the Board or, failing such amicable choice, by an arbiter appointed on its behalf by the Sheriff of Grampian, Highlands and Islands at Lochmaddy, the decision of such arbiter being final and binding upon the Trust, with the costs thereof being borne by the Trust.

ARTICLES of ASSOCIATION

of

Sgoil an Iochdair agus a'Choimhearsnachd

The Articles of Association provide the administrative constitution of the Company, establishing its membership, providing for meetings of members, establishing its board of management, providing for meetings of the board and confirming ancillary matters.

Ι

DEFINITIONS

- 1. (a) The regulations contained in Table C in the Companies (Tables A to F) Regulations 1985, or as may be amended or re-enacted, shall not apply to the Trust.
 - (b) In these Memorandum and Articles of Association, the words standing in the first column of the following table shall bear the meaning set opposite to them respectively in the second column thereof, if not inconsistent with the subject or context:

- (c) Words importing the singular number only shall include the plural number, and *vice versa;* and
- (d) Words importing the masculine gender only shall include the feminine gender.
- (e) Subject as aforesaid, any words or expressions defined in the Act shall, if not inconsistent with the subject or context, bear the same meanings in the Articles.
- 2. The Trust is established to achieve the Objects expressed in the Memorandum.

II GENERAL STRUCTURE OF THE TRUST

- 3 The structure of the Trust comprises:
 - (a) **Members** who have the right to attend the AGM (and any EGM) and have important powers under these Articles and the Act, particularly in electing people to serve as Trustees and taking decisions in relation to any changes to these Articles; and
 - (b) **Trustees** who hold regular meetings between each AGM, set the strategy and policy of the Trust, generally control and supervise the activities of the

Trust and, in particular, are responsible for monitoring its financial position and, where there are no employees or managers appointed, are responsible also for the day-to-day management of the Trust.

III MEMBERSHIP

- 4. The members of the Trust shall consist of the Subscribers and such other persons and organisations as are admitted to membership in terms of this Chapter.
- 5. Membership shall be open to:
 - (a) **Ordinary Members:** any individual aged 16 or over living in the Area of Benefit and any member of an amateur sports or recreational organisation which operates within the Area of Benefit.
 - (b) **Associate Members:** all other members, including all individuals under the age of 16 and all other local and business organisations.
- 6. Associate Members are neither eligible to stand for election to the Board nor to vote at any General Meeting.
- (a) Each member which is an organisation shall, within one month of admission to membership, appoint one named Authorised Representative and one named Depute. The Authorised Representative, whom failing the Depute, shall represent and act for such member at all General Meetings of the Trust. The Depute may represent and act for such member only in the absence of the Authorised Representative.
 - (b) Any change in the appointment of an Authorised Representative, and/or of a Depute, may be made at any time by the appointing member, but only by written notice served by the appointing member at the Office. Such notice will take effect two clear days after its receipt at the Office to allow sufficient time for the appointing member to serve a copy of the notice to anyone named therein.
 - (c) In the case of any dispute as to the correct Authorised Representative and/or Depute serving at any time, the matter will be settled by the Secretary in accordance with the most recent notice validly received at the Office.
- 8. Employees of the Trust shall not be eligible for membership and may not act as Authorised Representative or Depute of one. A person who becomes an employee of the Trust after admission to membership shall automatically cease to be a member or an Authorised Representative or Depute thereof.
- 9. The Board shall maintain a Register of Members, setting out all relevant details of each member and the relative category of membership, together where relevant with details of the Authorised Representative and Depute.

IV APPLICATION FOR MEMBERSHIP

- 10. Any individual who or organisation which wishes to become a member of the Trust must sign a written application for membership in the form prescribed, if any, by the Board from time to time and lodge it at the Office (or other address specified therein).
- 11. The Board shall consider such applications for membership promptly and shall

inform each applicant whether he, she or it has been successful and, where relevant, in which category of membership he, she or it shall belong, the decision of the Board in these respects being final. The Board may, at its discretion, refuse to admit any individual or organisation to membership, except for reasons of gender, sexuality, race, religion or politics.

12. A successful application for membership will not become effective until payment of the appropriate annual membership subscription has been received.

V MEMBERSHIP SUBSCRIPTIONS

- 13. Members shall be required to pay the appropriate annual membership subscription, if any.
- 14. The Ordinary Members may at any or each AGM fix any annual subscriptions (and, if relevant, different rates thereof for different categories). Only those members who have paid their current subscription (where these are fixed) are entitled to take part in and vote at any General Meeting.
- 15. If the membership subscription payable by any member remains outstanding for more than three calendar months after the date on which it fell due (and providing the member in question has been given at least one written reminder), the Board may expel that member from membership.
- 16. An individual or organisation who ceases (for whatever reason) to be a member shall not be entitled to any refund of membership subscription.

VI CESSATION OF MEMBERSHIP

- 17. Any member, or Authorised Representative or Depute thereof appointed in terms of Chapter III, may no longer serve as such in any one or more of the following events:
 - (a) if by notice in writing to the Office he, she or it resigns his, her or its membership; or
 - (b) if, being an individual, he or she becomes a bankrupt person, or insolvent or apparently insolvent or makes any arrangement or composition with his or her creditors generally; or
 - (c) if, being an individual, he or she becomes prohibited from being a Trustee (and, as such, a director of a limited company) by reason of any order made under the Company Directors Disqualification Act 1986 and every statutory modification and re-enactment thereof for the time being in force; or
 - (d) if the terms of Article 15 are invoked by the Board; or
 - (e) if a resolution that a member be removed from the Trust is passed by a majority of at least 75% of the Trustees present and voting at a meeting of the Board, of which not less than 14 days' previous notice specifying the intention to propose such resolution and the general grounds on which it is proposed shall have been sent to all Trustees and also to the member whose removal is in question, such member being entitled to be heard by the Board at that meeting; or
 - (f) if, being an individual, he or she dies; or
 - (g) if, being an organisation, it goes into receivership, goes into liquidation dissolves or otherwise ceases to exist.

18. On cessation of membership, membership is neither transferable nor assignable to any other individual or organisation.

VII

GENERAL MEETINGS (Meetings of Members)

- 19. The Board shall convene an Annual General Meeting in each year, at such time as it may determine, although the first AGM need not be held in the first year provided that it be held within 18 months after the date of incorporation of the Trust. Thereafter, not more than 15 months shall elapse between one AGM and the holding of the next.
- 20. The business of each AGM shall include:
 - (a) the report by the Chairman on the activities of the Trust;
 - (b) the election of Trustees;
 - (c) the fixing of annual subscriptions;
 - (d) the report of the independent financial examiner;
 - (e) approval of the annual accounts of the Trust; and
 - (f) appointment of the independent financial examiner.
- 21. (a) All General Meetings, other than AGMs, shall be called Extraordinary General Meetings.
 - (b) The Board may convene an EGM whenever it thinks fit.
 - (c) The Board must convene an EGM within 28 days of a valid requisition. To be valid, such requisition must be signed by not less than one-fifth of the Ordinary Members, must clearly state the objects of the meeting and must be deposited at the Office. The requisition may consist of several documents in like form each signed by one or more requisitionists.
- 22. (a) 14 clear days' notice at the least shall be given of every AGM and EGM.
 - (b) The notice shall specify the place, the day and the hour of meeting and, in the case of special business, the specific nature of that business.
 - (c) The notice shall be sent, in the manner specified in Chapter XX, to all members and to such persons or organisations as are under these Articles or under the Act entitled to receive such notices.
 - (d) With the consent of all the Ordinary Members having the right to attend and vote thereat, a General Meeting may be convened by such shorter notice as they may think fit in the circumstances.
 - (e) The notice must inform members of their right to appoint a proxy and explain the procedure for so doing.
 - (f) The accidental omission to give notice of a General Meeting to or the nonreceipt of such notice by, any members, persons or organisations entitled to receive notice thereof shall not invalidate any resolution passed at or proceedings of any AGM or EGM.

VIII

VOTING AT GENERAL MEETINGS

- 23. The chairman of the meeting (see Chapter X) shall endeavour to achieve consensus wherever possible but, if necessary, questions arising shall be decided by being put to the vote.
- 24. (a) Each Ordinary Member of the Trust shall have one vote, to be exercised in

person (which, where it is an organisation, is to be exercised in person by its Authorised Representative or Depute appointed in terms of Chapter III).

- (b) Associate Members shall have no vote.
- (c) Each member has a right to appoint a proxy, who will be entitled to vote at meetings, and exercise any or all of a members rights.
- (d) In the event of an equal number of votes for and against any resolution, the chairman of the meeting shall have a casting vote as well as any deliberative vote.
- 25. No objection shall be raised to the qualification of any voter except at the meeting or adjourned meeting at which the vote objected to is tendered, and every vote not disallowed at the meeting shall be valid. Any objection made in due time shall be referred to the chairman of the meeting whose decision shall be final and conclusive.
- 26. A resolution put to the vote at an AGM or EGM shall be decided verbally or on a show of hands, as appropriate, unless a secret ballot is demanded by the chairman of the meeting (or by at least two members present in person at the meeting and entitled to vote). A secret ballot may be demanded only either before any verbal vote or show of hands takes place.
- 27. If a secret ballot is demanded, it shall be taken immediately at the same meeting and shall be conducted in such a manner as the chairman of the meeting may direct and the result shall be declared at the same meeting at which the ballot was demanded.
- 28. At any General Meeting a resolution put to the vote of the meeting shall be voted upon as follows:
 - (a) Resolutions relating to the following matters shall require a special decision of not less than 75% of all Ordinary Members of the Trust who are present (or, being an organisation, whose Authorised Representative or Depute is present) and voting t the meeting, namely:
 - (i) to alter the name of the Trust; or
 - (ii) to amend the Objects; or
 - (iii) to amend these Articles; or
 - (iv) to wind up of the Trust in terms of Clause 9 (a) of the Memorandum of Association and, where relevant, any decision requiring to be taken in terms of Clause 9 (c) thereof; or
 - (v) to purchase or sell or to grant a lease over any heritable property owned by or leased to the Trust or any of its subsidiaries and to purchase or take the tenant's part in any lease or sub-lease of heritable property wherever situated; or
 - (vi) to form, acquire or dispose of any subsidiary; or
 - (vii) to grant any guarantee or indemnity to any party, other than any wholly-owned subsidiary of the Trust; or
 - (viii) to create or issue or allow to come into being any mortgage, security, charge or other encumbrance upon any part or parts of the property or assets of the Trust or to obtain any advance or credit in any form other than normal trade credit, or to create or issue by any subsidiary of any debenture or loan stock; or
 - (ix) to acquire or dispose, whether by the Trust or by any of its subsidiaries, of any shares of any other company or the participation or cessation of participation by the Trust or by any of its subsidiaries in any formal trust or joint venture; or
 - (x) all other Special Resolutions.

- (b) Ordinary business and ordinary resolutions shall be determined by a simple majority of all Ordinary Members of the Trust who are present (or, being an organisation, whose Authorised Representative or Depute is present) at the General Meeting.
- 29. A resolution in writing signed by or on behalf of all or a sufficient majority of the Ordinary Members (as specified in terms of Article 28) shall be as valid and effective as if the same had been passed at a General Meeting of the Trust duly convened and held. Such resolution may consist of several documents in the same form, each signed by one or more Ordinary Members.

IX QUORUM AT GENERAL MEETINGS

- 30. The quorum for a General Meeting shall be 10% of the Ordinary Members, present in person (or, if an organisation, via its Authorised Representative or Depute). No business shall be dealt with at any General Meeting unless a quorum is present.
- 31. If a quorum is not present within 15 minutes after the time at which the General Meeting was due to commence or if, during a General Meeting, a quorum ceases to be present the General Meeting shall stand adjourned to such time and place as may be fixed by the chairman of the meeting.

X CHAIRMAN OF GENERAL MEETINGS

32. The Chairman of the Trust, whom failing the Vice-Chairman of the Trust, shall act as chairman of each General Meeting. If neither the Chairman nor the Vice-Chairman is present and willing to act as chairman of the meeting within 15 minutes after the time at which the AGM or EGM in question was due to commence, the Trustees present shall elect from among themselves the Trustee who will act as chairman of that meeting.

XI COMPOSITION OF BOARD OF TRUSTEES

- 33. The affairs of the Trust shall be directed and managed by a Board of Trustees appointed in terms of this Chapter.
- 34. Unless otherwise determined by special resolution at a General Meeting (but not retrospectively), the number of Trustees shall be not less than three nor more than seven.
- 35. The minimum age of a trustee will be 16
- 36. (a) The Subscribers, and any one or more individual persons whom they choose to co-opt as Co-opted Trustees in terms of Article 37 (c), shall comprise the Interim Board of Trustees.
 - (b) The Interim Board shall remain in office until the first General Meeting of the Trust, to be held as soon as practicable after incorporation, at which time each Trustee on the Interim Board shall retire, but may remain eligible for election thereat (without the period of office between the date of incorporation and the first General Meeting counting as a term of office for the purposes of Article 38 (a) (iii)).

- 37. From and after the first General Meeting of the Trust, the Board shall comprise:
 - (a) up to three individual persons elected as Trustees by the Ordinary Members in terms of Article 38 (a) ("the Elected Trustees"); and
 - (b) up to three individual persons appointed by in terms of Article 37 (b) ("the Appointed Trustees"); and
 - (c) up to one individual person co-opted in terms of Article 38 (c) ("the Co-opted Trustee").

38. (a) Elected Trustees

- (i) At the first General Meeting held in terms of Article 36 (b), the Ordinary Members shall elect up to three Elected Trustees.
- (ii) Provided that the first General Meeting in terms of Article 36 (b) hereof is held before the first AGM, there shall be no change in or election of Trustees at the first AGM (except to the extent of filling any vacancies in the Board left over after the first General Meeting or caused by any retirals since).
- (iii) At the second and each subsequent AGM, one of the Elected Trustees shall retire from office. A retiring Elected Trustee shall retain office until the close or adjournment of the meeting. A retiring Trustee shall be eligible for re-election after one term of office, but no Trustee can serve more than two consecutive terms of office, without at least one year out of office before being eligible again.
- (iv) The Elected Trustee to retire at each AGM shall be the one to have been longest in office since their last election but, as between persons who were elected or last re-elected Trustees on the same day, the one to retire shall (unless they otherwise agree amongst themselves) be determined by lot.
- (v) Nomination of any Elected Trustee shall be in writing by not less than any two Ordinary Members. The nominee, who must be an Ordinary Member, shall confirm his or her willingness to act as an Elected Trustee if elected and if required shall provide a statement to explain the nominee's suitability. Except for the General Meeting held in terms of Article 36 (b), at which nominations can be served validly until immediately before the start of the meeting itself, all nominations to be valid must be delivered to the Office not less than seven days prior to the date of the AGM in question.
- (vi) Election of any Elected Trustee shall be by vote of the Ordinary Members, each Ordinary Member having one vote for each vacancy in the Elected Trustees on the Board.

(b) Appointed Trustees

- (i) Up to one Trustee shall be appointed by the Local Authority.
- (ii) Up to one Trustee shall be appointed by the Parent Council of Iochdair School.
- (iii) Up to one Trustee shall be appointed as a representative of the amateur sports and recreational organisations which are Ordinary Members of the Trust.
- (iv) In respect of the appointment of each of the Appointed Trustees, the following shall apply:
 - (A) On receipt of the Notice for each AGM of the Trust, including the first General Meeting held after incorporation, each appointing body in terms of sub-clauses (i), (ii) and (iii) hereof shall serve a written notice at the Office to intimate the Trustee

being appointed by it or them at the AGM. Such written notice must be at the Office not less than forty-eight hours before the start of the Annual General Meeting, failing which the Trustee previously appointed by it or them shall remain in office.

- (B) Each appointing body may appoint or remove its or their own appointed Trustee at any time, by written notice to that effect served at the Office not less than forty-eight hours before the meeting at which the change is to take effect. Any notice intimated within forty-eight hours of a meeting of the Board or of the members of the Trust shall not take effect until the following meeting.
- (c) **Co-opted Trustee**

Up to one individual may be co-opted from time to time by the Board of Trustees itself, as follows:

- (i) Subject to Article 38 (c) (iii), a Co-opted Trustee shall serve until the next AGM after his or her co-option.
- (ii) A Co-opted Trustee can be re-co-opted at such next AGM.
- (iii) A Co-opted Trustee can be removed from office at any time by a simple majority of the Board.
- (iv) For the avoidance of doubt, a Co-opted Trustee may participate fully in and vote at all Board meetings which he or she attends.
- 39. The Board may from time to time fill any casual vacancy arising as a result of the retiral (or deemed retiral for any reason) of any Trustee elected in terms of Article 38 (a), from or after the date of such retiral or deemed retiral until the next AGM.
- 40. The office of Trustee shall *ipso facto* be vacated:
 - (a) if he or she is employed by or holds any office of profit under or is employed by the Trust (except where the provisions of Clause 6 (d) (ii) of the Memorandum shall apply); or
 - (b) if he or she becomes a bankrupt person, or insolvent or apparently insolvent or makes any arrangement or composition with his or her creditors generally; or
 - (c) if he or she becomes prohibited from being a Trustee (and, as such, a director of a limited company) by reason of any order made under the Company Directors Disqualification Act 1986 and every statutory modification and reenactment thereof for the time being in force; or
 - (d) if he or she becomes incapable for medical reasons of fulfilling the duties of his or her office and such incapacity, as certified by two medical practitioners, is expected to continue for a period of more than six months from the date or later date of such certification; or
 - (e) if he or she is absent (without permission of the Board) from more than three consecutive meetings of the Board, and the Board resolves to remove him or her from office; or
 - (f) if by notice in writing to the Office he or she resigns his or her office; or
 - (g) if he or she dies.

XII CHAIRMAN AND VICE-CHAIRMAN

41. The Board shall meet as soon as practicable immediately after each AGM to appoint both a Chairman and a Vice-Chairman of the Trust from the Board (either of whom can be the Co-opted Trustee).

XIII CONFLICTS OF INTEREST

- 42. (a) All Trustees and employees of the Trust have an obligation to notify any interests, including conflicts of interest, to the Secretary, as they arise and at least annually.
 - (b) The Board will instruct the Secretary to maintain a Register of Interests in such form as it may from time to time determine which shall be open for inspection at the Office by both the Board and members of the Trust and, with the express prior written approval of the Trustee or employee concerned, by members of the public.
- 43. Whenever a Trustee finds that a conflict of interest may potentially arise or is actually arising, he or she has a duty to declare this either in general terms to the Secretary or specifically to the Board meeting in question. It will be up to the Chairman in the former circumstances and up to the chairman of the meeting in question in the latter circumstances to determine whether the potential or real conflict simply be noted in the Minutes of any relevant meeting, and/or whether the Trustee in question, whilst being permitted to remain in the meeting, must not partake in discussions or decisions relating to such matter, or whether the Trustee in question should require to be absent from that particular element of the meeting. In terms of Article 44 (b), where a Trustee leaves, or is required to leave, the meeting in question, he or she no longer forms part of the quorum thereat.

XIV

QUORUM AT BOARD MEETINGS

- 44. (a) The quorum for Board meetings shall be not less than 50% of all the Trustees. No business shall be dealt with at a Board meeting unless a quorum is present.
 - (b) A Trustee shall not be counted in the quorum at a meeting (or at least the relevant part thereof) in relation to a resolution on which, whether because of personal interest or otherwise, he or she is not entitled to vote.

XV

PROCEEDINGS AT BOARD MEETINGS

- 45. The direction and business of the Trust shall be managed by the Board, who may pay all such expenses of, and preliminary and incidental to, the promotion, formation, establishment and registration of the Trust as it thinks fit. The Board may exercise all such powers of the Trust, and do on behalf of the Trust all such acts as may be exercised and done by the Trust, and as are not by the Act or by these Articles required to be exercised or done by the members in General Meeting, subject nevertheless to any regulation of these Articles and to the provisions of the Act.
- 46. The Board may act notwithstanding any vacancy in it, but where the number of Trustees falls below the minimum number specified in Article 34 may only do so for the purpose of appointing sufficient Trustees to match or exceed that minimum.
- 47. (a) All cheques, promissory notes, drafts, bills of exchange and other negotiable instruments, and all receipts for monies paid to the Trust, shall be signed, drawn, accepted, endorsed or otherwise executed, as the case may be, in such manner as the Board shall from time to time by resolution determine.

- (b) The banking account or accounts of the Trust shall be kept in such bank or building society and/or banks or building societies as the Board shall from time to time determine.
- 48. (a) Meetings of the Board may take place in person or by telephone conference call, video conference call or by any other collective electronic means approved from time to time by the Board.
 - (b) Not less than 14 clear days' notice in writing shall be given of any meeting of the Board at which a decision in relation to any of the matters referred to in Articles 17 (e) and 28 (a) is to be made, which notice shall be accompanied by an agenda and any papers relevant to the matter to be decided. All other Board meetings shall require not less than 7 days' prior notice, unless all Trustees agree unanimously in writing to dispense with such notice on any specific occasion.
 - (c) A Trustee may, and on the request of a Trustee the Company Secretary shall, at any time, summon a meeting of the Board by notice served upon all Trustees, to take place at a reasonably convenient time and date.
- 48. The Chairman, whom failing the Vice-Chairman, shall be entitled to preside as chairman of all Board meetings at which he or she shall be present. If at any meeting neither the Chairman nor the Vice-Chairman is present and willing to act as chairman of the meeting within 15 minutes after the time appointed for holding the meeting, the remaining Trustees may appoint one of the Trustees to be chairman of the Board meeting, which failing the meeting shall be adjourned until a time when the Chairman or Vice-Chairman will be available.
- 50. (a) The chairman of the Board meeting shall endeavour to achieve consensus wherever possible but, if necessary, questions arising shall be decided by being put to the vote, on a show of hands only, each Trustee present having one vote.
 - (b) The decisions listed in Article 28 (a) cannot be taken by the Trustees alone, but must also be taken by the Ordinary Members in terms of Article 28 (a) and only thereafter acted upon by the Board as directed by the Ordinary Members.
 - (c) In the event of an equal number of votes for and against any resolution at a Board meeting, the chairman of the meeting shall have a casting vote as well as a deliberative vote.
- 51. The Board may delegate any of its powers to sub-committees, each consisting of not less than one Trustee and such other person or persons as it thinks fit. Any sub-committee so formed shall, in the exercise of the powers so delegated, conform to any remit and regulations imposed on it by the Board. The meetings and proceedings of any such sub-committee shall be governed by the provisions of these Articles for regulating the meetings and proceedings of the Board so far as the same shall not be superseded by any regulations made by the Board. Such sub-committee shall regularly and promptly circulate, or ensure the regular and prompt circulation of, the minutes of its meetings to all Trustees.
- 52. The Board shall cause minutes to be made of all appointments of officers made by it and of the proceedings of all General Meetings and of all Board meetings and of subcommittees, including the names of those present, and all business transacted at such meetings and any such minutes of any meeting, if purporting to be signed after approval, either by the chairman of such meeting, or by the chairman of the next

succeeding meeting, shall be sufficient evidence without any further proof of the facts therein stated.

- 53. All acts *bona fide* done by any Board meeting, or of any sub-committee, or by any person acting as a Trustee shall, notwithstanding it be afterwards discovered that there was some defect in the appointment or continuance in office of any such Trustee or person acting as aforesaid, or that they or any of them were disqualified, be as valid as if every such person had been duly appointed or had duly continued in office and was qualified to be a Trustee.
- 54. No alteration of the Memorandum or Articles and no direction given by Special Resolution shall invalidate any prior act of the Board which would have been valid if that alteration had not been made or that direction had not been given.
- 55. A resolution in writing (whether one single document signed by all or a sufficient majority of the Trustees or all or a sufficient majority of the members of any subcommittee), whether in one or several documents in the same form each signed by one or more Trustees or members of any relative sub-committee as appropriate, shall be as valid and effectual as if it had been passed at a meeting of the Board or of such sub-committee duly convened and constituted.
- 56. The Board may invite or allow any person to attend and speak, but not to vote, at any meeting of the Board or of its sub-committees.

XVI ANCILLARY REGULATIONS

57. The Board may from time to time promulgate and review any Ancillary Regulations, which are to be subordinate at all times to the Memorandum of Association and these Articles, as it deems necessary and appropriate to provide additional explanation and guidance to members.

XVII

COMPANY SECRETARY, MINUTE SECRETARY, TREASURER & PRINCIPAL OFFICER

- 58. The Board shall appoint a Company Secretary for such term, at such remuneration (if any), and upon such conditions as it may think fit. The Company Secretary may be removed by the Board at any time, subject to the terms of any prevailing contract.
- 59. The Board may appoint a Minute Secretary, for the purposes of Article 52, for such term, at such remuneration (if any), and upon such conditions as it may think fit. The Minute Secretary may be removed by the Board at any time, subject to the terms of any prevailing contract.
- 60. The Board may appoint a Treasurer for such term and upon such conditions as it may think fit. The Treasurer may be removed by the Board at any time, subject to the terms of any prevailing contract. Whilst in post, the Treasurer may be required to attend (but shall have no vote at) Board meetings during his or her tenure as Treasurer, except any part or parts thereof dealing with his or her employment or remuneration, or any other matter which the Board wish to keep confidential to itself.
- 61. The Board may appoint a Principal Officer of the Trust on such terms (including a

decision on the most appropriate job title) and conditions as it may think fit, who shall attend Board and Sub-Committee meetings as appropriate or required, but without any vote thereat.

XVIII

HONORARY PATRON(S)

62. The Ordinary Members in General Meeting may, on a proposal from the Board, agree to the appointment of one or more Honorary Patrons of the Trust, who would be appointed either for such fixed period as those Members determine or for an unspecified period until such appointment be terminated by them. The Honorary Patron or Patrons would be entitled to notice of all General Meetings and to attend and contribute to discussion but not vote thereat.

XIX

ACCOUNTS

- 63. The Board shall cause accounting records to be kept in accordance with the requirements of the Act and other relevant regulations.
- 64. The accounting records shall be maintained or overseen by the Treasurer (if one is appointed), or otherwise by the Board, shall be kept at the Office (or at such other place or places as the Board shall think fit) and shall always be open to the inspection of the Trustees. The Board shall from time to time determine whether and to what extent and at what times and places and under what conditions or regulations the accounting records of the Trust or any of them shall be open to the inspection of the members of the Trust.
- 65. Once at least in every year, or as otherwise provided for by the Act, the accounts of the Trust shall be examined and the correctness of the income and expenditure account and balance sheet ascertained by an independent financial examiner, who shall be appointed by the Board on the direction of members in General Meeting.
- 66. (a) At each AGM, the Board shall provide the members with an income and expenditure account for the period since the last preceding accounting reference date or (in the case of the first account since the incorporation of the Trust) together with a proper balance sheet made up as at the same date.
 - (b) Every such balance sheet shall be accompanied by proper reports of the Board and the independent financial examiner thereof.
 - (c) Copies of such account, balance sheet and reports (all of which shall be framed in accordance with any statutory requirements for the time being in force) shall, not less than 14 clear days before the date of the General Meeting at which they are to be laid, and in terms of Chapter XX, be delivered or sent to the independent financial examiner and to all members, or otherwise be available for inspection on the website of the Trust (with the independent financial examiner and all members being made aware that they are so available for inspection there).

XX NOTICES

67. A notice may be served by the Trust upon any member, either personally or by sending it by post, fax, e-mail or other appropriate electronic means, addressed to such member at his or her or its registered address as appearing in the Register of

Members.

- 68. Any notice, whether served by post or otherwise, shall be deemed to have been served on the day following that on which the letter containing the same is put into the post or is otherwise despatched.
- 69. A member present at any meeting of the Trust shall be deemed to have received notice of the meeting and, where requisite, of the purpose for which it was called.
- 70. The business of the Trust and all its correspondence with and notification to or from members may be conducted equally validly and effectively as by post if transmitted by fax or e-mail or other appropriate electronic means to or from any member of the Trust (except where that member specifically requests all such correspondence and notification by post) or otherwise if publicised on the website of the Trust where the Trust has advised each member of this and has taken due steps to notify by other reasonable means all other members who state that they do not have access to the Internet.

XXI

INDEMNITY

71. Subject to the provisions of Section 310 of the Act, the Trustees, or member of any sub-committee, the Secretary and all other officers or employees for the time being of the Trust shall be indemnified out of the funds of the Trust against all loss, costs and charges which they may respectively incur or be put to on account of any contract, deed, act, matter, or thing done, entered into, executed, or permitted by them respectively, on behalf of the Trust and each of them shall be chargeable only for so much money as he or she may actually receive and they shall not be answerable for the acts, receipts, neglects or defaults of each other, but each of them for his or her own acts, receipts, neglects or defaults only. Subject as aforesaid, no Trustee or member of any sub-committee, the Secretary, Treasurer or any officer or employee, or their respective heirs, executors or administrators, shall be liable for any loss or expense happening to the Trust through the insufficiency or deficiency of title to any property acquired for or on behalf of the Trust or for the insufficiency or deficiency of any obligation or security in or upon which any of the funds of the Trust shall be invested or for any loss or damage arising from the bankruptcy, insolvency or wrongful act of any person with whom any monies, securities or effects shall be deposited, or for any loss, damage or misfortune whatsoever which shall happen in the execution of the duties of his or her office or in relation thereto, unless the same shall happen through his or her own fraud, wilful neglect, default, breach of duty or breach of trust.

XXII ALTERATION OF MEMORANDUM & ARTICLES OF ASSOCIATION

72. Subject to the terms of Article 28 (a), no alteration in the Memorandum and/or these Articles may at any time be made unless by the decision of 75% of the Ordinary Members present and voting at a General Meeting called specifically (but not necessarily exclusively) for the purpose.

XXIII DISSOLUTION

73. Clause 9 of the Memorandum of Association of the Trust, relating to the winding up and dissolution of the Trust, shall have effect as if its provisions were repeated in
